

CHALLENGE RULES LES GÉANTS

Les GÉANTS is an ultra-distance cycling race starting from Annecy in full autonomy.

Two formats are available:

- 300km and 700km in road
- 250 and 600km in gravel

The different routes follow the most beautiful Alpine passes and are marked out by checkpoints (depending on the distance). As the event takes place on open roads, participants are required to strictly follow the traffic regulations

I. ORGANISATION

Les GEANTS is organised by the association "La Brigade Matchy". Association loi 1901 registered on April 28, 2019, residing 39 avenue des Romains, 74000 Annecy.

II. ROUTES

Les GEANTS consists in a route to follow divided by multiple checkpoints from the start to the finish. All riders must go through these checkpoints, failing which they will be disqualified.

III. AUTONOMY

Participants take part in the event in full autonomy.

They must be able to engage in a demanding event and its associated difficulties. They must be physically self-sufficient, both in terms of equipment and food. They must also be able to deal with unforeseen circumstances (lack of food, mechanical problems) and know how to find their way around on their own.

Total autonomy implies :

The obligation to carry one's own equipment throughout the event, and to accept the organisation's controls.

No outside assistance on the course, or being accompanied for all or part of the race by a non-participant.

If necessary, participants may obtain supplies from shops along the route. They can also sleep in hotels or with local people.

IV. PARTICIPATION

Physical abilities

Les GEANTS is an ultra-long-distance event reserved for well-trained cyclists. Participants must be able to ride long distances in difficult conditions.

Risk acceptance

Participants are fully aware that ultra-cycling is a dangerous activity due to :

- Traffic on open roads
- Physically demanding routes
- Hostile weather conditions, especially in the mountains
- Night time and lack of sleep

They must :

- Be well trained
- Know how to handle difficulties linked to physical effort and conditions on their own
- Be able to solve mechanical problems

Their safety depends on themselves and their ability to solve their own problems. Participants unreservedly accept all risks to which they expose themselves during the event, including the risk of traffic

accidents, the risk of falls and trauma, the risk of injury, and the risk of experiencing symptoms of extreme fatigue. They take part in the event at their own risk. They agree to hold the organiser fully responsible for any damage that may occur during the event. No recourse will be possible.

Minimum age

Les GEANTS is an event open to all participants who have reached the age of majority on the event start date.

V. EQUIPMENT

Mandatory :

- GPS tracker supplied by the organiser
- GPS (updated and last generation to follow the map)
- Helmet
- Waterproof jacket
- High-visibility reflective tape OR reflective vest
- Front and rear bike light with battery and recharge to last the duration of the course
- Wrench (multitool type)

- Bike pump (no CO2 cartridge)
- 2 inner tubes min.
- Telephone (to join mandatory the what's app group) + charging cord + charging device
- survival blanket
- Minimum 1.5-liter water supply
- ID card or passport + photocopy

Recommended:

Debit / credit card

Chain oil

Brake pads

First-aid kit

Self-medication with

Anti-Inflammatory-Non-Steroidal drugs is strongly discouraged.

VI. BIBS

Bib numbers will be issued upon presentation of the following:

- Identification
- Compulsory equipment

Numbers must be visible throughout the event.

Pick up: - Thursday 13th of August 2026 (from 10 am to 7pm)

Mandatory briefing: Thursday 13th of August 2026 (7:30pm).

VII. SAFETY

Les GEANTS is first and foremost a personal challenge and a race for those who want it. Indeed cyclists cannot replace the need to respect the traffic regulations. Cycling on open roads is dangerous because of drivers, motorcyclists, other cyclists and even animals. It is the responsibility of each participant to render assistance or help to any person he/she encounters in danger, and to notify emergency services if necessary. Participants are aware that, in the event of an accident during the event, emergency services may be late in arriving or may be insufficient. In all cases, they must inform the organiser.

VIII. TIME LIMITS AND RANKING

In order to ensure the logistical management of the event, including the presence of volunteers at the various checkpoints and a rescue team, a time limit has been set for completing the various courses:

300km and 250km: 30h

700km and 600km: 72h

As participants are riding on open roads, they must comply with the traffic regulations. Any participant who jeopardises his or her own safety or that of other cyclists and/or road users will be disqualified from the event.

Each finisher will receive a finishing time calculated by the GPS tracker.

The organisers will not be establishing a ranking at the finish. As a reminder, the primary objective of the event is to ensure that you reach the end of the course in full physical and mental health.

IX. WITHDRAWAL

Participants abandoning the event must notify the organiser and return home or to the finish by their own means. It is strongly recommended to anticipate this eventuality and the possible repatriation options.

In the event of withdrawal, participants must return the equipment loaned (GPS Tracker) to the race organiser's address: 5 avenue du Stand, 74000 ANNECY before the end of the event Monday 17th of August 7am.

In the case of injury during the race, the assistance of a first-aider is possible and recommended. Participants are required to listen to the advice of professionals.

Any costs arising from the use of rescue or evacuation services, even of an exceptional nature, will be borne by the participants assisted. The organiser reserves the right to disqualify any participant showing signs of advanced fatigue or excessive injury.

X. PENALTIES DISQUALIFICATION

Conduct subject to penalty:

- Littering
- Disrespect for others
- Failure to assist a participant in difficulty
- Invisible bib
- Non-compliance with local rules of the road
- Failure to respect the course

Conduct subject to disqualification:

- Cheating
- Absence of compulsory equipment
- Prohibited assistance

- Refusal to obey an order from the organiser
- Absence of GPS tracker signal for more than 24 hours
- Failure to pass through a checkpoint
- Use of doping products
- Driving on roads prohibited

XI. INSURANCE

The organiser would like to draw participants' attention to the importance of taking out personal insurance to cover bodily injury incurred as a result of sporting activities. Participants should contact their insurer to find out about suitable insurance. For participants who wish, "cancellation" insurance is offered at the time of registration on the registration platform. This option must be taken out before the order is validated and, under certain conditions established by the insurer chosen by the organiser, enables the registration fees paid to be reimbursed. If the rider has not taken out cancellation insurance, he/she will not be able to claim a refund from the

organisation. Repatriation insurance is compulsory to take part in the challenge.

XII. IMAGE RIGHTS

In accordance with provisions relating to image rights, participants allow the organiser and its technical service providers to take photos, videos or digital recordings during the event. The images may be exploited and used directly by the organisation in any form and on any medium, for an unlimited territory, without

time limit, in full or in excerpts, and in particular: press, books, digital media, exhibitions, advertising, public screenings, competitions, websites, social networks. The organiser expressly refrains from using the photos in any way that might infringe on privacy or reputation, and from using the photos, videos or digital recordings in any way that might be prejudicial. All disputes arising from the interpretation or execution of the present contract shall be submitted to the exclusive jurisdiction of the French courts.

XIII. EXPLOITATION RIGHTS

The organiser owns the exploitation rights to the event it organises under the legally registered "Les Géants" brand. All still or filmed images of the event are therefore the exclusive property of the organiser. Any communication about the event or use of the event in any form or medium whatsoever must respect the name of the event, the registered trademark and the express agreement of the organiser. Any commercial use of the event's name and/or images is subject to a written contract with the organiser.
